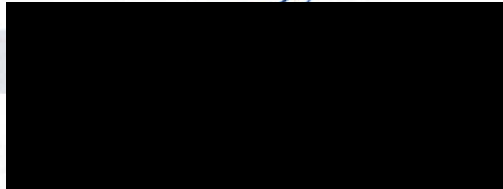

NLWA has a policy which aims for 95% of residents to live within two miles (measured as a straight line) of a Household Waste Recycling Centre (or Reuse and Recycling Centre as referred to by the London Mayor and now by NLWA). Therefore the protection of existing sites until replacements are in place fits with NLWA's policy on provision, agreed in June 2010.
