

Responsible Purchasing

Your organisation can decrease carbon emissions, reduce waste, save money and improve its environmental impact by choosing to buy more sustainable products. Here are some simple, cost effective ways you can minimise the environmental impact of your purchasing:

- Think about whether a purchase is really necessary. Could you cut down on the use of natural resources by hiring instead of buying?
- Choose durable products and make purchases based on whole life cost not just lowest price. It may be more cost effective to buy a product which lasts longer or an efficient product with lower running costs, even if it is more expensive up front.
- Choose products with minimal packaging. These could be cheaper, and you will save money on waste disposal costs.

Since its launch in 2001, members of the Green Procurement Code have diverted 1.3 million tonnes of waste from landfill and in 2006 alone, the purchase of green products resulted in 175,000 tonnes of carbon dioxide savings.

- Think about whether a product and its packaging can be reused or recycled before buying it.
- Avoid hazardous or toxic materials.
- Always buy recycled paper. If you do need to buy virgin paper (or any other wood product) ensure that it comes from well managed FSC certified forests. Look for this symbol on the product.



- Choose efficient products which use less energy and water. For recommended products visit www.eca.gov.uk/etl and www.eca-water.gov.uk
- Where possible choose local suppliers to reduce emissions from transport and support the local economy.
- **Buy second-hand.** This will be cheaper and reduce the use of natural resources.
- **Ask your suppliers about their environmental credentials.** Aim to only do business with companies which have high environmental standards.
